LSC Party Policies

- 1. Parties must be reserved 14 days in advance for LSC to guarantee adequate staff (lifeguards, manager-on-duty, bartender, etc.)
- 2. A Party Reservation Form is required for parties of 12 and more.
- 3. A rental fee is required for reserved party space for 12 or more:

Rental fee includes: reserved party area, 1 bartender, trash removal and clean-up after party. Additional bartenders are available for a fee.

- 4. Party date is not guaranteed until deposit is received.
- 5. Additional Non-Member Guest Fees
 - a. Member Hosts are responsible for guest fees.* Fees are to be paid prior to party's end time. *Please see www.lincolnshireswimclub.com for current guest fee rates.
 - b. Guest fees for *children 10 and under* is increased to \$15 per non-member. This is to cover the cost of additional lifeguards to ensure safety.
 - c. Non-member guests must have a signed waiver on file. Waiver is available on www.lincolnshireswimclub.com
 - d. Parties of more than 12 non-member guests must be pre-arranged with the LSC social chair.
- 6. Member Host must remain on premises for duration of the party and is responsible for the behavior and any damage caused by party guests.
- 7. In case of inclement weather (below 65 degrees at the start of the party, rain or lightning), management reserves the right to reschedule.
- 8. Pool rental groups must abide by all Lincolnshire Swim Club rules. The Club Manager has the authority to enforce any additional rules that will protect the safety of patrons and staff and the security of the facility. All participants are subject to a swim test.
